**OPEN WATER COURSE INFORMATION:**

Student supplied equipment for the course will consist of mask, snorkel, dive boots and scuba fins; mask defog, slap strap and mesh gear bag are highly recommended. In order to prevent improper selection of the equipment, it is recommended that these items be purchased after a counseling session.

A classroom and swimming pool will be provided by the facility. Scuba equipment will be provided for the Open Water Level 1 course and the designated open water weekend only. If a wetsuit is to be needed for the open water weekend, a fee and a deposit for rental is required. If a student is unable to attend the scheduled open water weekend, other training arrangements must be made within 30 days for the make-up work, or an additional fee will be required. Park entrance fees are not included and will vary at each location.

**CONTINUING EDUCATION COURSE INFORMATION:**

A classroom and swimming pool will be provided by the facility. The student for this course will supply academic supplies and scuba equipment, if applicable. If a wetsuit is needed for the open water weekend, a fee and a deposit for rental is required. If a student is unable to attend the scheduled open water weekend, other training arrangements must be made with the instructor and the facility. The student will be responsible for renting the scuba equipment for the make-up training. Arrangements must be made within 30 days for the make-up work, or an additional fee will be required.
